### Waiver of Liability and Release of Claims

#### COVID-19 SAFETY INFORMATION:

While participating in the Vita-Learn 2022 Dynamic Landscapes Conference, participants must adhere to the guidelines stated in the Duty of Care received in advance of the conference.

Participants are further encouraged to follow CDC guidelines including practicing hand hygiene, and “social distancing” to reduce the risks of exposure to COVID-19. Participants are required to wear face coverings. ***Vermont Department of Health (VDH) recommends wearing a high-quality mask to help limit the spread of COVID-19, including variants like Omicron.*** Because COVID-19 is extremely contagious and is spread mainly from person-to-person contact, the Dynamic Landscapes Conference Duty of Care includes preventative measures to reduce the spread of COVID-19. However, Vita-Learn cannot guarantee that Meeting participants, volunteers, partners, or others in attendance will not become infected with COVID-19.

In light of the ongoing spread of COVID-19, individuals who fall within any of the categories below should not engage in the Dynamic Landscapes events. By attending the 2022 Dynamic Landscapes Conference, you certify that you do not fall into either of the following categories:

1. Individuals who currently or within the past ten (10) days have experienced any symptoms associated with COVID-19, which include fever, cough, and shortness of breath among others;
2. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

#### DUTY TO SELF-MONITOR:

Participants and volunteers agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath) and, contact Jeff Mao, Vita-Learn Executive Director, at 207-798-2460 if a participant experiences symptoms of COVID-19 within 14 days after participating or volunteering at the event.

I acknowledge that I derive personal satisfaction and a benefit by virtue of my participation and/or voluntarism with Vita-Learn, and I willingly engage in events associated with the Dynamic Landscapes Conference.

**RELEASE AND WAIVER.**

I HEREBY RELEASE, WAIVE AND FOREVER DISCHARGE ANY AND ALL LIABILITY, CLAIMS, AND DEMANDS OF WHATEVER KIND OR NATURE AGAINST VITA-LEARN AND ITS AFFILIATED PARTNERS AND SPONSORS, INCLUDING IN EACH CASE, WITHOUT LIMITATION, THEIR DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, AND AGENTS (THE “RELEASED PARTIES”), EITHER IN LAW OR IN EQUITY, TO THE FULLEST EXTENT PERMISSIBLE BY LAW, INCLUDING BUT NOT LIMITED TO DAMAGES OR LOSSES CAUSED BY THE NEGLIGENCE, FAULT OR CONDUCT OF ANY KIND ON THE PART OF THE RELEASED PARTIES, INCLUDING BUT NOT LIMITED TO DEATH, BODILY INJURY, ILLNESS, ECONOMIC LOSS OR OUT OF POCKET EXPENSES, OR LOSS OR DAMAGE TO PROPERTY, WHICH I, MY HEIRS, ASSIGNEES, NEXT OF KIN AND/OR LEGALLY APPOINTED OR DESIGNATED REPRESENTATIVES, MAY HAVE OR WHICH MAY HEREINAFTER ACCRUE ON MY BEHALF, WHICH ARISE OR MAY HEREAFTER ARISE FROM MY PARTICIPATION WITH THE ACTIVITY.

**ASSUMPTION OF THE RISK.** I acknowledge and understand the following:

1. Participation includes possible exposure to and illness from infectious diseases including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist;
2. I knowingly and freely assume all such risks related to illness and infectious diseases, such as COVID-19, even if arising from the negligence or fault of the Released Parties; and
3. I hereby knowingly assume the risk of injury, harm and loss associated with the Meeting, including any injury, harm and loss caused by the negligence, fault or conduct of any kind on the part of the Released Parties.

**MEDICAL ACKNOWLEDGMENT AND RELEASE.** I acknowledge the health risks associated with the conference, including but not limited to transient dizziness, lightheaded, fainting, nausea, muscle cramping, musculoskeletal injury, joint pains, sprains and strains, heart attack, stroke, or sudden death. I agree that if I experience any of these or any other symptoms during the conference, I will discontinue my participation immediately and seek appropriate medical attention.

**I DO HEREBY RELEASE AND FOREVER DISCHARGE THE RELEASED PARTIES FROM ANY CLAIM WHATSOEVER WHICH ARISES OR MAY HEREAFTER ARISE ON ACCOUNT OF ANY FIRST AID, TREATMENT, OR SERVICE RENDERED IN CONNECTION WITH MY PARTICIPATION IN THE ACTIVITY.**

As a participant, volunteer, or attendee, You recognize that your participation, involvement and/or attendance at any activity or event associated with the 2022 Dynamic Landscapes Conference hosted by Vita-Learn ("Activity") is voluntary and may result in personal injury (including death) and/or property damage.
